TV Bracket Assembly Hardware

#### STEP 1

Read and understand all of the enclosed instructions and verify that all parts are present and appear in good working order before you begin.

#### STEP 2

Decide if you'd rather use the Leveling Feet or Wheels on the cart Base. Choose option A or B to continue.

Using one M12 Nut, one M12 Spring Washer and one M12 Washer per wheel, screw the four wheels into the legs, as shown in Figure 1.

(B) Screw the four Leveling Feet into the legs, as shown in Figure 2.

#### STEP 3

Attach the Post to the Base using the M6 bolts, as illustrated in Figure 3.





#### **STEP 4**

Loosen the screws where the mounting bracket attaches to the post poles. Hold the mounting bracket to keep it from falling too quickly while adjusting the height to the ideal position. Tighten the screws to secure the mounting bracket at the desired height. See Figure 4.

#### STEP 5

Attach the Metal Tray to the post using the Metal Shelf Clips and M6 bolts. See Figure 5.





#### STEP 6

In the hardware bag provided, locate the 4 pan head bolts that fit the thread pattern for your television or Audio Mount<sup>™</sup>. With the two Vertical Brackets centered on the back of the TV or Audio Mount<sup>™</sup>, gently thread the screws into the holes by hand. DO NOT USE AN ELECTRIC OR BATTERY DRILL until you are certain you have the right size thread. DO NOT OVER TIGHTEN the screws (Figure 6). When installing an Audio Mount<sup>™</sup>, mount the television to the Audio Mount<sup>™</sup> as instructed in the Audio Mount<sup>™</sup> Owner's Manual and then mount the brackets to the back of the mount, as illustrated in Figure 6.

NOTE: If attaching directly to a TV, make sure to use the proper bolts and washers that correspond to the mounting holes on the back of the TV. Tighten by hand first or damage to the mounting holes can occur. Some TVs without a flat back may require the use of a spacer when attaching the brackets. If applicable, make sure the two TV brackets are even and that they're using the same mounting holes on the bracket. Uneven assembly will cause the TV screen to slant.

NOTE: You will need at least 2 people to finish this mounting procedure. To avoid possible injury, do not attempt to mount the TV alone.

#### **STEP 7**

Hang the pre-assembled TV unit on the Mounting Plate. Tighten the safety screws at the bottom of each Bracket to secure (Figure 8).

#### **STEP 8**

Route the cables from the television down one side of the post and secure with the plastic snap-on Cable Clips, as illustrated in Figure 9.

Metra Electronics Corporation warrants to the original purchaser of the registered or identified product for a period of five years from the date of purchase, that the product shall be free of defects in design, material and workmanship, and subject to the limitations set forth below; Metra Electronics Corporation will repair or replace, at its option, any defective unit. This warranty is applicable only to the original purchaser and is not assignable or transferable. Metra hereby warrants to the original retail purchaser of this product that should this product or any part thereof, under normal use and conditions, prove to be defective in material or workmanship within five years from date of original purchase, such defect(s) will be repaired or replaced with reconditioned product (Metra's option) without charge for parts and repair labor. Purchaser must return the product to Metra, return receipt requested or by other means that confirms delivery and Metra shall make the said repairs or replaced. In that instance Metra shall in its discretion attempt to replace the product with a substantially similar product in model or design or pay the purchaser a sum for the then fair market value of the price, considering the amount of time since sale, and the use of the product.
